TYPES OF PRACTICE OF PHARMACY SERVICE

This list is designed to provide examples of practice of pharmacy service activities that may be included in this section of a promotion dossier. It is not all-inclusive of activities that fulfill this requirement.

DEFINITION

Practice of pharmacy service includes pharmaceutical care provided to a Candidate's patients, larger patient populations, and contributions to the profession. This may include direct patient-centered interactions (e.g., primary care, patient counseling, etc.), practice management, and/or administration. Any activities that contribute in these areas on behalf of the department, college and/or university or that directly contribute to the mission and vision of the department, college and/or university may be considered as evidence of practice service.

PRACTICE SITE

CLINICAL SITE SERVICE:

- Development
- Continuation
- Expansion
- Coordination across multiple systems and/or sites

PATIENT CARE:

- Education of the public at site (e.g., follow-up health classes)
- Administrative responsibilities (e.g., implementation and management of site procedures for rebates, patient assistance, prior authorization)

CONSULTATIONS:

- · Ancillary services
- · Legal requests

PRACTICE MANAGEMENT AND/OR ADMINISTRATION

- Policy and/or procedures
- Medication safety
- Quality improvement; project assessment; hospital initiatives
- Procuring resources; establishing partnerships
- Strategic planning (including justification of new services)
- Promotion and/or advocacy of pharmacy services
- Management of personnel (e.g., hiring, training, evaluating, remediation, dismissal)
- Site committees (e.g., defining roles and responsibilities, serving as member or chair, level of involvement)
- Formulary management (e.g., Drug utilization evaluation, class review, formulary request, non-formulary request)
- Drug shortage and recall management
- Reaccreditation (e.g., The Joint Commission, specialty certifications)
- Accredited programs (e.g., American Society of Health System Pharmacists Technician Program)
- Investigational drugs
